Service in the fire profession carries a significant responsibility and requires a strong commitment. Oregon's fire service is grounded in tradition, teamwork, and professionalism, and the Silvertown Fire District is proud of its more than 100 years of dedicated service to the community and its ongoing commitment to public safety.

The Silvertown Fire District is one of fifteen fire agencies in Marion County, Oregon. The district covers approximately 108 square miles and includes the incorporated cities of Silvertown and Scotts Mills. The remaining service area consists of agricultural lands, commercial properties, private forestlands, and both developed and undeveloped recreational areas. The district serves a population of just over 21,500 residents and borders five neighboring fire districts. Mutual and automatic aid are regularly provided and received, and the district responds to a wide range of emergency incidents and public education events.

Our community is diverse, comprising permanent residents, commuters, part-time residents, and visitors. The area hosts more than 300,000 visitors annually, drawn by the many recreational opportunities available throughout the district.
